## **Data Protection Notice for Personnel Recruiting**

This notice describes how Berndorf Band GmbH, Leobersdorfer Straße 26, 2560 Berndorf, Austria ("we") processes your personal data in connection with your application to us.

## 1. Purposes of data processing

- Citizenship
- Type of job for which you would like to apply (e.g. sales manager, unsolicited application)
- Type of application (e.g. apprenticeship, internship)
- Scope of employment
- Earliest entry date
- Termination notice period
- Your salary expectations
- Photo
- Resume
- Military service/civil service
- Education (school, university, courses)
- Employment relationships and internships
- Responsibilities and task areas
- Personal skills and competencies

- Information about interests and hobbies
- Signature
- Certificates and diplomas
- Other data provided by you in the application process

We transmit this data to our group companies with your consent (art. 6 para. 1 (a) GDPR).

#### 3. Transmission of your personal data

For the above purposes, we will send your personal data to the following recipients:

## 4. Storage period

Your personal data will only be stored by us for as long as we reasonably deem necessary for the purposes set out in point 1 and as permitted under applicable law. In any case, we store your personal data as long as the statutory retention requirements apply, or limitation periods for potential legal claims have not yet expired.

#### 5. Your rights in connection with personal data

Under applicable law, you may, among other things, have the right (subject to applicable law) to: (i) verify whether and what personal data we hold about you and obtain copies of that data; (ii) require the correction, supplementation, or deletion of your personal data, which is false or has not been processed in a legally compliant manner; (iii) to require us to restrict the processing of your

personal data; (iv) to object in certain circumstances to the processing of your personal data or withdraw your prior consent to the processing of your data; (v) to require the transferability of data; (vi) to know the identity of third parties to whom your personal data is transmitted; and (vii) to lodge a complaint with the competent authority.
